## **GRANT APPLICATION GUIDELINES**

**Application Due Date: Monday, November 7, 2011**

*The BOOK of DISCIPLINE 2004, OF THE UNITED METHODIST CHURCH*

*¶ 264.5 Peace with Justice Sunday... has been celebrated with an offering on the First Sunday After Pentecost. Congregations are to observe Peace with Justice Sunday on this date or on another date appropriate to the local church....*

*¶ 264.5a) the annual conference treasurer shall retain 50 percent of the receipts for Peace with Justice ministries in the annual conference....*

**Funding Source:** The Peace with Justice Offering is retained in the North Georgia Conference from the “Peace with Justice Sunday Offering” in June of each year. Fifty percent of monies collected go to the awarding of grants. The balance goes to the General Church.

**Eligibility:** To apply for funding, the applicant is required to represent a United Methodist local congregation in the North Georgia Conference. The awarded grant monies are to help initiate, enable or sustain a church’s justice ministry, advocate peace with justice issues or ministries that serve in that capacity.

**Criteria:** A local congregation or ministry which addresses cultural, economic, social and environmental justice issues by identifying the root cause of injustice and creating the ministries and advocacy components for working toward ending injustices.
